There is an administrative fee of \$40.00 incurred on the third day for any vehicles still on the property. There is a second administrative fee of \$60.00 incurred on the thirtieth day for any vehicles still on the property.

To retrieve the vehicle the owner must show the title or the current tag registration, proper U.S. government issued ID, and pay for the tow and any other services in cash. The owner of the vehicle at the time of tow is responsible for all bills incurred. If the accident was not your fault the other insurance company may pay the bill, but it is your responsibility to insure that this is done in a timely manner.

The vehicle along with its contents will be deemed abandoned after 30 days and will be sold at public auction in an attempt to pay for the charges. If the sale of the vehicle with its contents does not bring the accumulated charges you may be sued for the balance still owed. OCGA 40-11-2

If your vehicle is not worth retrieving, due to an accident or other mechanical problems, Statewide Wrecker Service, Inc. will in some cases accept the vehicle for a portion of the charges if done in a timely manner. In some cases, payment in full is required.

LEAVING THE VEHICLE WITHOUT PAYING THE CHARGES MAY RESULT IN A \$500.00 FINE PAYABLE TO GWINNETT COUNTY, OCGA 40-11, ALONG WITH THE ENTIRE TOWING AND STORAGE BILLS PAYABLE TO STATEWIDE WRECKER SERVICE, INC.
